# 1 Universe

### Whole and Part

Living organisms are entities where the whole and the parts mutually depend on each other. Indeed, the whole does depend on the parts, but the whole is not simply the sum of the parts; it always presents characteristics that are not found in the individual parts.

A living organism is a whole that is organized and structured in such a way that each part interacts with and controls the others. This whole, while containing the parts, has a unity that carries a meaning beyond the parts.

The organism establishes its own distinction between itself and the environment and decides its interactions with the environment. A living system integrates the contradiction of openness and closure at the boundary.

The self forms itself by determining its own boundaries. The boundaries the self creates between itself and the environment both distinguish them and simultaneously allow mutual penetration. Boundaries integrate the contradictions of identity and difference between the self and the environment. In this sense, the self is open to the environment through the boundary, while simultaneously being closed, and closed while being open. Boundaries separate as well as unite the self and the environment.

The individual organism, whether a plant or an animal, is covered by an outer layer, which not only distinguishes the individual from the environment but also facilitates the exchange of external and internal elements, maintaining continuity between the individual and the environment. Here, opposing concepts such as inside and outside, self and other, identity and difference intersect and permeate each other.

# Interaction and Mutual Recognition

Living organisms constantly exchange matter, energy, and information with their external environment, maintaining their internal order with flexibility. Under this interaction between

the inside and outside, the process of continually changing internally while maintaining their identity is what constitutes life.

The maintenance of homeostasis in living organisms is also carried out through the interaction of various organs. It is not driven by the command of a single organ or a single substance. Rather, it arises naturally through the mutual interaction of various organs and substances. Thus, the essence of life lies in this interaction, not in any single organ or substance.

Biological phenomena are sustained by the continuous interaction with the external environment. DNA itself is a living entity, constantly interpreting the external environment and engaging in life processes through the interaction between the inside and the outside. This interaction is life itself.

Genes are information. Information is relationship. Relationship is interaction. Therefore, it is neither selfish nor altruistic. It is both selfish and altruistic.

Living organisms, both internally and externally, create harmony as each element recognizes and interacts with others. The ability of life to form order must be understood as the ability of mutual recognition between individuals that make up the organism.

The neurons in the brain are also oscillators, and millions of these neurons synchronize, leading to functional integration. Even neurons that are far apart synchronize, producing brain functions. Our thoughts, emotions, memories, and behavioral patterns arise from the synchronized phase between neurons, producing coordinated activity, allowing the brain to function as a unified entity. This synchronization is nothing other than recognition.

# **Activity of Perception**

Perception is an event. It encompasses not only what is perceived and the perceiver but also their relationship, as well as the surrounding circumstances and context. It is a unique, momentary event that occurs right here and now. From the event of each moment itself, both what is perceived and the perceiver emerge.

Perception is the recognition of the relations between things, including the perceiver. No cognition can exist without relations. Furthermore, these relations are always dynamic. As the perceiver changes, the relations between things change, and in response to these changing relations, perception also changes.

Perception is not passive, but active. As we move within the world, we generate events and recognize them. Engaging in activity is what constitutes perception. Therefore, recognition changes depending on how one acts.

Between action and perception, there is continuous interaction and a cooperative circular process. Here, what is active is also passive, and what is passive is also active.

# Perception and Action

Perception is an act. Therefore, depending on how the act is performed, the world appears in various ways. As a result, the world that each observer envisions appears differently.

Perception originates from action, not the other way around. Action does not originate from perception. Moreover, perception changes along with changes in action.

Perception arises through the encounter of the subject and the environment in the changing actions and the changing environment. The perceptual judgment of the object is established through the resonance between the object and the observer.

The subject recognizes the environment by acting within it. The perceiver exists within the world they perceive, and recognition is established through interaction with the world that is being perceived.

The subject extracts meaning from the environment through action in the environment The meaning and value of the environment change as a result of the changes in the acting subject. Meaning and value emerge from the circular correlation between the subject and the

environment.

Living systems are influenced by the environment and also influence it, shaping themselves through interaction with the environment. As living systems change in relation to the environment, they also change the environment, and both the subject and environment evolve synergistically.

The subject influences the environment, and the environment influences the subject, with both the subject and environment undergoing spiral changes. As the environment creates the subject, the subject also creates the environment. Through this interaction, both the subject and the environment undergo self-formation.

Through the spiral and cyclical interaction of action, recognition, and form in the subjectenvironment relationship, evolution occurs. In this way, life forms create new forms through the interaction between the subject and the environment.

Through the experiments performed by scientists, the world can be changed. The act of experimentation in natural science involves cutting into nature with a hypothesis. Scientific

experiments are not conducted outside nature, but within it, forcing nature to reveal its secrets. Naturally, like any coerced confession, the image thus revealed is not the original, unaltered truth.

Science, too, is historically generated and changes over time. Science itself has changed our understanding of nature through the development of tools and discoveries, that is leaps in action. This shows that the way we perceive the world changes through observation and action.

# Mutual generation and Complexification

Life is a free existence beyond determinism.

The forms and directions that living beings can take are filled with contingency. For a living being, any possibility exists. However, because life contains this contingency, it is also free. Plants grow against gravity, and birds fly in the sky. The world of life is one of freedom and spontaneity.

# 4 Society

### Mutual connectivity

The society we engage in is also constituted by interconnectedness, and it generates and changes through the interaction between elements and their interaction with the environment.
